**Subject: Renewal of Undergraduate Seats (MBBS) of
Government Medical College, Tiruppur, Tamil Nadu for the year
AY- 2025-26 - regarding.**

Sir/Madam,

I am directed to refer to the Public Notice issued by UGMEB vide dated 01.11.2024 uploaded on the NMC website on 06.11.2024, directing all medical colleges with valid Letters of Permission (LoP) to upload the details/data of their respective institutions on the NMC portal for the annual declaration, as required under the NMC Act, 2019 and various regulations issued by NMC from time to time, for the grant of renewal of MBBS seats for the academic year 2025-26.

2. Based on the details furnished by your college, the experts assessed the submissions, and accordingly, a Notice dated **05.05.2025** was issued highlighting the following deficiencies observed during the assessment:

1. Faculty position/attendance is deficient in Sixteen (16) out of Twenty (20) departments.
2. Clinical Pathology & Cytopathology are inadequate.
3. Number of Cadavers are inadequate.
4. Financial proofs not attached in declaration forms i.e. Dr. D. Boopathi Raja, Dr. Sarvanan P, Dr. S. Madhumalai.
5. Lack of Teaching experience for faculty appointment i.e. Dr. T. Muthu Vel.

3. Subsequently, the compliance report submitted by your Institution was also evaluated by the Assessors; however, amongst other deficiencies, following key deficiencies were again highlighted w.r.t. your College/Institution:

1. Faculty position/attendance is still deficient in Sixteen (16) out of Twenty (20) departments.
2. Necessary action may be taken with regard to lack of teaching experience for faculty appointment.

Further, it has been observed that during the renewal process for the previous year AY 2024-25, conditional renewal was granted in view of the substantive nature of deficiencies in your College.

4. The Competent Authority has reviewed the Annual Declaration Report (ADR) submitted by your college/institution and also the deficiencies pointed out by the experts. The compliance report submitted by the college has not been found to be convincing and satisfactory.

5. However, UGMEB has taken a lenient view and **decided to grant conditional renewal of 100 UG (MBBS) seats** for the academic year 2025-26, **subject to rectification of deficiencies with in four months from the issuance of this letter.**

6. A further review will be conducted after four months, and if the deficiencies are found to persist at that time, stringent action will be initiated as mandated under Chapter III, Clause 8 of the Maintenance of Standards of Medical Education Regulations (MSMER), 2023, and any other applicable rules or regulations.

7. If the College/Institution is not satisfied and aggrieved with the decision of the Board, you may prefer an appeal before the Commission under Section 9, Chapter IV of the Maintenance of Standards of Medical Education Regulations, 2023, (MSMER, 2023) within Sixty (60) days of the issue of this letter.
